 - We are not out of 100G ports, we are out of *redundant* 100G ports. We can not make any more redundant 100G LAGs. Some rearranging has already been done in the past to free up 100G ports.
 - The new card would cost about \$22,000.
- Reid: MICE welcomes any and all remote switches. MICE is completely agnostic on everything, as long as it is not to the detriment of the exchange. MICE does not buy transit; MICE does not buy cache fill. We are a cooperative. MICE is possibly the only cooperative. Exchanges after us were approved with the same legal status as exchanges that came before us.
